

Directions to the Mount

From West and Northwest:

- I-74 East to I-275 South to Kilby Rd.
- Right on Kilby Rd.
- Left on U.S. 50 West/River Rd.
- Left on Bender Rd.
- Left on Delhi Rd.
- Right on Neeb Rd.

From South:

- I-75/71 North to Cincinnati.
- Exit on U.S. 50 West/River Rd.
- Right on Fairbanks which becomes Delhi Rd.
- Left on Need Rd.

From North:

- I-75 South to Freeman Ave.
- Right on U.S. 50 West/River Rd.
- Right on Fairbanks which becomes Delhi Rd.
- Left on Neeb Rd.

From East and Northeast:

- U.S. 50 towards downtown Cincinnati
- Stay on U.S. 50 West/River Rd.
- Right on Fairbanks which becomes Delhi Rd.
- Left on Neeb Rd.

NOTE: Always check traffic conditions and road closures prior to traveling.
