Conference Objectives

1. Define the criteria for diagnosis of hyperlipidemia in children, pharmacologic management and criteria for referral to cardiology.
2. Discuss the history of diabetes medications and injectable/oral hypoglycemic medications.
3. Discuss new medications being used for pediatric conditions, mechanism of action, cost effectiveness, no longer recommended medications and new black box warnings.
4. Describe medications considered safe for breastfeeding moms, medications that need to be avoided during breastfeeding and ideas to increase supply.
5. Identify the Schedule II medication drug class, discuss the commonly used drugs that have potential for abuse and describe treatment protocols for overdose in the emergency department/outpatient setting.
6. Discuss receiving/responding to a subpoena per ORC 4723.29, answering the question about whether to testify per ORC 2317.02 and responsibilities for attending the hearing.
7. Discuss the appropriate pharmacologic management of seizures/febrile seizures, including medications that impact antiepileptic medications and the child on the ketogenic diet.
